Emissions reduction targets

In order to continue our progress to achieving Net Zero, our emissions reduction target is to reduce our GHG emissions (scopes 1, 2 & 3) from our recorded baseline by 25% by 2024, 50% by 2027, and by a minimum of 90% by 2030.

In 2023, there has been an overall increase of 11% (YoY emissions comparison for all scopes) accounted for by a 3% increase in scope 1 emissions (+185.72 kgCO2e), 2% reduction in scope 2 emissions (-31.35 kgCO2e), and a 14% increase in scope 3 emissions (+3,788.81 kgCO2e).


To remain on track to meet our interval reduction plan targets we will need to reduce our emissions by 33% (-12,041.72 kgCO2e) by year end 2024.

Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 556.40 kgCO $_2$ e, a 54% reduction against the 2022 baseline for scope 1 and 2 and the measures will be in effect when performing the contract.

- Stricter thermostat control for the office capped at 20°c has contributed to a significant reduction if gas consumption.
- Installation of motion sensor LED lighting in communal office areas has reduced our electricity consumption.
- Introduction of a Sustainable Procurement Policy to encourage environmentally conscious supply chain decisions.
- Introduction of a Workplace Travel Policy to encourage sustainable travel options for business travel and the use of efficient travel planning to reduce fuel consumption and the need for unnecessary/repeat trips to be made.

In the future we hope to implement further measures such as:

- Replacing our company vehicle fleet with EVs.
- Focus on making our supply chain greener and setting higher environmental requirements to be added to our approved suppliers register.
- B Corp certification.
- Carbon offsetting initiatives.
